IT'S YOUR CHOICE

You are never required to purchase insurance:

- that is offered by your distributor;
- from a person who is assigned to you; or
- to obtain a better interest rate or any other benefit.

Even if you are required to be insured, **you do not have to** purchase the insurance that is being offered. **You can choose** your insurance product and your insurer.



HOW TO CHOOSE

To choose the insurance product that's right for you, we recommend that you read the summary that describes the insurance product and that must be provided to you.



DISTRIBUTOR REMUNERATION

A portion of the amount you pay for the insurance will be paid to the distributor as remuneration.

The distributor **must** tell you when the remuneration exceeds 30% of that amount.



RIGHT TO CANCEL

The Act allows you to rescind an insurance contract, **at no cost**, within 10 days after the purchase of your insurance. However, the insurer may grant you a longer period of time. After that time, fees may apply if you cancel the insurance. **Ask** your distributor about the period of time granted to cancel it **at no cost**.

If the cost of the insurance is added to the financing amount and you cancel the insurance, your monthly financing payments might not change. Instead, the refund could be used **to shorten the financing period. Ask your distributor for details**.

INTRODUCTION

This Product Summary will provide an overview of the Single Trip - Trip Protection Plan. This summary will help you determine if this insurance is right for you without the advice of an insurance advisor. This document highlights the benefits, exclusions, limitations and restrictions that apply to this coverage. Refer to the certificate of insurance for the complete terms and conditions. YOUR RIGHT TO EXAMINE

The Right to Examine period gives you 10 days to review your certificate of insurance and confirm it meets your needs. This 10-day period allows you to return the certificate of insurance for a full refund if you have not left on your trip and have not filed a claim.

PRODUCT DESCRIPTION

The Single Trip - Trip Protection Plan provides worldwide coverage for Canadian residents while travelling outside their home province or territory of residence.

Coverage begins on the effective date and ends on the expiry date. These dates are determined at the time of purchase and can be found on your Declaration of Coverage Letter.

NOTICE

General Exclusions apply to all benefits. Refer to the General Exclusions and Limitations section in the certificate of insurance.

DO YOU QUALIFY FOR THIS COVERAGE? (ELIGIBILITY)

As of the date you apply for this coverage and the date you choose your coverage to begin, you must:

- be a resident of Canada;
- be a BMO Financial Group customer;
- purchase this coverage before you leave on your trip;
- pay for the insurance.

TRIP PROTECTION - TRIP CANCELLATION, TRIP INTERRUPTION/DELAY

You will receive payment for non-refundable, non-transferable, prepaid travel expenses if you need to cancel, interrupt or delay your trip as a result of a covered event.

- **Trip Cancellation:** Up to the amount you insure to a maximum of \$20,000, less any available refunds, per certificate of insurance. Trip Cancellation occurs before you leave.
- **Trip Interruption/Delay:** Up to \$3,000 per insured person, less any available refunds. Trip Interruption occurs after you leave but before you return home. Trip Delay occurs when you cannot return home as scheduled.

Covered Reasons

The following includes some key reasons that are covered: **Health**

- Sickness (including being diagnosed with COVID-19), injury or death
- Complications of pregnancy within the first 28 weeks of pregnancy or following the full-term birth of a child
- Side effects resulting from vaccines required for your trip

Work

- Job transfer requiring a change of residence
- · Involuntary job loss
- Cancellation of a planned business meeting due to death or hospitalization of the person you are meeting with

Legal

- Jury duty or subpoenaed witness
- •

Other

- Refusal of a travel visa (Trip Cancellation)
- Delay of scheduled departure for specific reasons
- Extreme weather
- Canadian government issues a travel advisory after you book the trip (Trip Cancellation) or after you depart on the trip (Trip Interruption)

Limitations

Trip Protection Limitations include but are not limited to the following:

- If you do not contact your travel supplier and the Operations Centre within 48 hours of a claim event it may reduce the amount of reimbursement.
- The insurer only issues payment for the nonrefundable portions of prepaid travel arrangements.

IF YOU NEED TO CANCEL, INTERRUPT OR DELAY YOUR TRIP

Contact the Operations Centre and your travel suppliers within 48 hours of the cancellation, interruption or delay of the trip.

FLIGHT DELAY

If there is a delay in the arrival or departure of your regularly scheduled flight of more than **6 hours** the insurer will pay up to \$500 for additional accommodation and travelling expenses.

Refer to the Flight Delay Benefits section of the certificate of insurance.

BAGGAGE AND PERSONAL EFFECTS COVERAGE

Provides coverage for loss or damage to your personal items while travelling up to \$1,000 per insured person including up to \$500 for delayed baggage. The overall maximum is \$3,000 for all insured persons combined.

Baggage Coverage Limitations

If you submit a claim for an item that is part of a pair or set, only the value of the item claimed will be paid.

FLIGHT ACCIDENT & TRAVEL ACCIDENT COVERAGE

Provides Flight Accident coverage of up to \$100,000 and Travel Accident Coverage of up to \$50,000 in the event you suffer a loss as a result of an accidental injury that occurs while on your trip.

LIMITATION

In the event a loss is eligible for payment under both the Flight Accident benefit and the Travel Accident benefit or if you suffer more than one (1) of the life-altering losses described above, only the largest insured loss is payable.



AGGREGATE LIMIT

The total aggregate limit for all Travel Accident claims is \$10 million.

GENERAL EXCLUSIONS AND LIMITATIONS

General Exclusions and Limitations

You will not be paid for expenses that arise from or relate to any of the following:

1. Pre-existing conditions

A sickness, injury or medical condition that is not stable before the stability period found on your Declaration of Coverage Letter.

The stability period that applies to you is based on your age. If over 60, it is based on the answers you give on the medical questionnaire.

- 2. Situations you were aware of at the time of booking the trip that could prevent you from travelling as planned (applies to Trip Cancellation Benefits only).
- 3. Situations you were aware of before departing on your trip that could result in you interrupting your trip or delaying your return (applies to Trip Interruption/Trip Delay Benefits only).
- 4. Some pregnancy situations.
- 5. Dangerous activities, criminal offences or illegal acts.
- 6. Mental, nervous or emotional disorders and/or acts of self-harm.
- 7. Alcohol or drug abuse, or misuse of medication.
- 8. Professional sports or high-risk activities.
- 9. Radioactive, biological or chemical contamination.
- 10. A physician tells you not to travel.
- 11. A travel supplier stops service or (defaults this does not include travel agents, and brokers).
- 12. Travel to support someone whose sickness or death causes cancellation or interruption.
- 13. A travel advisory issued by the Canadian government.
- 14. An epidemic or pandemic illness, except where referenced and covered under the policy.

GENERAL PROVISIONS

Additional Insurance - This insurance only pays amounts that are beyond amounts payable from your government health insurance plan (if applicable) or any other insurance plan.

Currency - All amounts in the certificate of insurance are in Canadian currency and reimbursements will be provided in Canadian currency.

Legal Action - Legal action against the insurer must begin within the timeline determined by the Insurance Act or Limitations Act of your home province or territory of residence. For Quebec residents this is in the Quebec Civil Code.

Misinformation - If you provide incorrect information when you apply for this insurance or when you submit a claim, the insurer may choose to void your coverage. Any claim submitted will not be paid.

Third Party Liability - If you incur expenses due to a third party, the insurer may take legal action against the third party at the insurer's expense. You will support the insurer by co-operating with them and supplying any documentation they may need. You agree to do nothing to interfere in the insurer's right to recover funds.

ADDITIONAL INFORMATION

What if you decide to stay longer?

If you decide to travel longer than the number of days you have purchased, call the Operations Centre before the expiry date shown on your Declaration of Coverage Letter.

A trip extension can be purchased if there is no event that will cause a claim at the time of purchasing the additional days.

Refer to the When Coverage Ends section of the certificate of insurance.

Refunds

After the 10-day Right to Examine period you may still request a refund but penalties may apply. You may only request a refund if:

- you cancel the trip before the departure date; and
- any penalties come into effect; or
- all penalties have been waived by the travel suppliers.

Contact the Operations Centre to request a refund.

Refer to the Your Right to Obtain a Refund section of the certificate of insurance.

Premium Calculations

Premiums are calculated based on:

- · your trip length
- · cost of the trip
- the schedule of premium rates in effect (subject to change)
- number of insured persons
- provincial or territorial taxes

MAKING A CLAIM

How do I submit a claim?

You must contact the Allianz Global Assistance Operations Centre as soon as reasonably possible to report a claim. Upon receipt of the notice, the Operations Centre will provide you with the appropriate claim forms.

HOW TO FILE A COMPLAINT

THE ACT RESPECTING THE DISTRIBUTION OF FINANCIAL PRODUCTS AND SERVICES GIVES YOU IMPORTANT RIGHTS.

The Act allows you to rescind an insurance contract, **without penalty**, within 10 days of the date on which it is signed. However, the insurer may grant you a longer period.

To rescind the contract, you must give the insurer notice, within that time, by registered mail or any other means that allows you to obtain an acknowledgement of receipt.

Despite the rescission of the insurance contract, the first contract entered into will remain in force. Caution, it is possible that you may lose advantageous conditions as a result of this insurance contract; contact your distributor or consult your contract.

After the expiry of the applicable time, you may rescind the insurance contract at any time; however, penalties may apply.
